RYAN HAS NOT BOUGHT BONDS

So Declares President Tucker-Is Perfectly Satisfied With Result of Negotiations.

WASHINGTON, D. C., May 6 .- "Yes George Tucker, of the Jamestown Expo-sition Company, after a visit to Presi-dent Roosevelt to-day. "The board of directors has issued a mortgage of \$400,000, and I have every reason to be-lieve it will be taken up in the next

few days."

Mr. Tucker denied the report that Thomas F. Ryan had bought in the bonds to cover the mertgage, but said that he was perfectly satisfied with the result of his financial negotiations. With this money in hand, he said, the exposition, with afteen good working days, would be completed.



According to the ordinance submitted by the Mayor the civic flag of the city of Richmond will be of blue silk or bunting, three feet wide by five feet long, or of any isze with these proportions preserved. Inches the end with a white fringe of the same material as the flag and not less than four inches wide, having on each side and in the centre a Norman shield inches (or, if the size of the flag is varied, bearing the same proportion to the size of the flag), on the obverse shield, painted or embroidered is the ancient seal of the city of Richmond in use prior to 1872, and inscribed thereon, "Richmond, Va. It is learned, however, that some of the roads will fight the order in the courts. It is said that there is some doubt whether the Seaboard Air Line will contest the order. It is asserted that the representatives of the legal department of the Seaboard Air Line are opposed to attempting to everthrow the order of the commission.

It is said that the counsel of the Seaboard Air Line advises strongly against taking the order to the courts, giving as reason therefor that the people are not in humor to stand further opposition on the part of the roads toward the commission, or attempts at legislation aimed to regulate railway charges.

It 'was impossible to ascertain whether all of the roads will unite in fighting the order of the commission. It may be asserted with absolute positiveness that the Southern will take the case to the courts, as has been stated in this correspondence.
