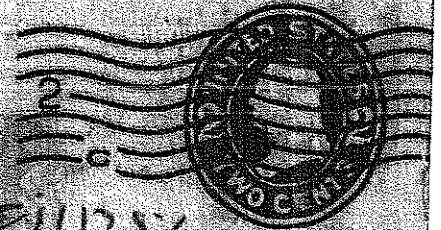

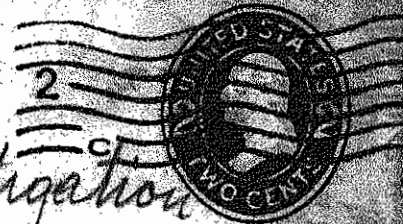

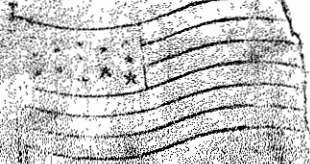
to make over that Report and head it

To the Honorable Governor
Indianapolis Ind.

Where-as we have learned from the public press that John J McNamra Sec'y of the Structural Iron and Bridge Workers of America has been", (through the connivance of the Governor of Indiana and the local officials of Indianapolis) kidnaped and railroaded to jail at Losangeles Cal. without due consideration of his constitutional rights; therefore be it resolved-- That we the members of the Marietta Trade and Labor Assembly and Local Marietta of the Socialist Party as lawabiding citizens decry such Anarchistic Action on the part of those who are sworn to inforse law and order, and believing that such acts strike at the very foundation of good government. We therefore call upon all lawabiding citizens of the state of Indiana to rebuke such action at the polls at their first oportunity and that all others though the U. S. use their influence to this end . We firmly believe that the very fact that such unlawful acts as were found necessary on the part of the prosicution to, attain their end is significant of the innocence of John J McNamra and Brother James.

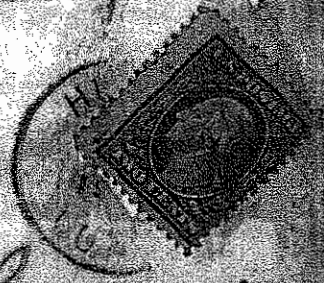

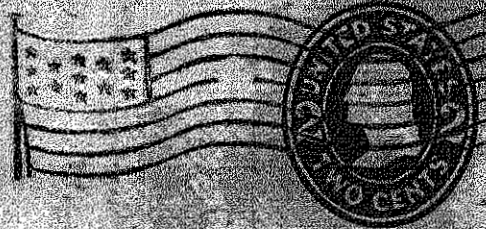
The country at large, as you know, feel very much gratified over the proceedings and termination of the McNamara cases, and that you are entitled to great credit.
