**Abstract:** This collection contains personal and professional papers which reflect the wartime career and the later writing of Witness to Barbarism by attorney Horace R. Hansen. Collection materials track his role as prosecutor at the Dachau war-crimes trials, his acquaintance with five of Hitler's chief stenographers, and his interviews of Dr. Ewald Reynitz (one of the five stenographers) for his account of the war and the Dachau trials. Materials include U.S. Army documents, interview transcripts, correspondence, personal notes and notebooks, photographs, publications, newspapers, and other papers.

**Biographical/Historical Information:** Horace R. Hansen was born on February 20, 1910, and grew up in the Midway area of St. Paul, Minnesota. He attended Central High School and graduated from the University of Minnesota, then the St. Paul College of Law in 1933. While in law school, he became a friend of former Chief Justice of the United States, Warren Burger, who was also attending the law school. They remained friends and corresponded after Chief Justice Burger moved to Washington D.C. Horace was proud of his friendship with the Chief Justice and treasured the letters he received from the Chief.

Following graduation from law school, Horace worked for the Industrial Commission as a Workers' Compensation attorney. While at the Commission, he met Larry Hazen, also a Compensation attorney who later joined with Horace to found the firm of Hansen and Hazen in 1946. During the 1930s, Horace was very active in the Democratic Farmer-Labor Party and worked for various social causes in St. Paul with Warren Burger. Horace was also very active in the Cooperative Movement.

Horace joined the Ramsey County Attorney's staff as a prosecuting attorney in the early 1940s. World War II interrupted his practice, where he served as a lieutenant in an U.S. Army replacement troop. At the end of the war, he became a Captain in the Judge Advocate General's Corp. Horace had many interesting experiences during his service in World War II and wrote long letters during the war to his friends in St. Paul. They were widely circulated and published in the St. Paul Dispatch. These letters are now part of the permanent records of the Ramsey County Historical Society. He also took many pictures while traveling through Europe. At the end of the war, Horace became part of the prosecution team that prosecuted the Germans for war crimes. Horace worked on part of the Nuremberg trials but primarily worked as a prosecutor at Dachau. In connection with his work as a prosecutor, Horace met many interesting German people including several of Adolf Hitler's personal recorders. He collected many photographs of the concentration camps and prepared a manuscript for publication regarding his experiences during the war and as a war crimes prosecutor.

After completing his prosecution duties, Horace returned to St. Paul and joined with Larry Hazen and three others to form a new firm known as Hansen, Robins, Davis, Lyons & Hazen. Later that year, Horace and Larry formed their own partnership. From 1948 to 1963, there were various attorneys that were associated with Larry and Horace in the practice, which by then was known as Hansen, Hazen & Lynch. Some of these lawyers were Joseph Dillon, a former mayor of St. Paul, Ramsey County District Judge James Lynch, Phillip Klein, and Warren Newcombe, a former attorney for Great Northern Railroad.

Horace was a general practitioner but was widely recognized as an expert in insurance, banking and health law. He served on the board of Directors of the American National Bank

& Trust Company for 25 years and chaired the committee of the Minnesota State Bar Association which recodified the Minnesota insurance laws in the 1970s. Horace served as the Degree of Honor Protective Association general counsel for over twenty years, served as a general counsel for the Minnesota League of Credit Unions, and also served as general counsel for the Independent Bankers Association of America.

His work in banking law sent him to Washington, D.C., on numerous occasions to testify on pending legislation before Congress. In addition, because of the national scope of Horace's work representing small, independent banks against large banks and bank holding companies, Horace participated in many banking "test" cases around the United States in various state and federal courts.

As an outgrowth from his early days in the Cooperative Movement, Horace obtained authorization from then-Minnesota Attorney General Miles Lord to charter the first health maintenance organization in Minnesota. Horace was one of the founders of the Group Health Association of America and served as its counsel for many years also. During the tenure of Minnesota Governor Orville Freeman, Horace was invited by the Governor to consider an appointment to the Minnesota Supreme Court, but he declined.

Apart from his law practice, Horace was active in social organization, serving as one of the founders of the North Oaks Golf Club. He was also one of the founders of the Norske Torske Klubben, a club made up of people with Norwegian heritage.

Horace was a lawyer from the "old school" and a true gentleman. He was especially unique in his ability to look at a legal issue as if it had never been presented previously. This permitted him to let his mind roam and consider the problem from all facets. Even after his retirement, Horace retained his keen interest in the law. He often consulted with members of his firm now known as Hansen, Dordell, Bradt, Odlaug & Bradt.

Horace married Ruth Laugen (1925-1998) in the summer of 1951. They had three children: John C. Hansen, Jean H. Doth, and Gail N. Tromburg. Horace and Ruth built a house in Mahtomedi, Minnesota, where they spent their first eight years. In 1959, they moved to North Oaks, Minnesota, where Horace and Ruth spent the rest of their lives. Horace died at this home on October 4, 1995, while writing a fiction book.

This biography was provided by two of Hansen's colleagues at Hansen, Dordell, Bradt, Odlaug & Bradt, Gene Bradt and Wayne Dordell.

## Scope and content

The Horace Hansen Papers Collection largely consists of materials related to Hansen's time in the military during WWII and his later research and writing of his book, *Witness to Barbarism*, about his experiences in Europe. Hansen's military career began with him serving as a lieutenant in a U.S. Army replacement troop, but by the end of the war he was a Captain in the Judge Advocate General's Corp and became part of the prosecution team that prosecuted the Germans for war crimes. He worked on part of the Nuremberg trials by primarily was a prosecutor at Dachau. Hansen's career can be tracked through the materials he kept, including Army documents (1943-1946), maps, ephemera (various programs, tickets, menus, and signs), newspaper clippings, and postcards. He also took many photographs and wrote a series of letters home, which were widely circulated and published in the *St. Paul Dispatch*. After the war, Hansen began working on what would become his book, *Witness to Barbarism*. Hansen became close to many people he met in Germany, including several of Hitler's stenographers, who he interviewed and corresponded with. The interview materials and letters from and to Hansen are contained within this collection, in addition to his notes, research materials, and various drafts of the book. Beyond this, Hansen kept his notes from speeches given about his experiences during the war and many publications, including military manuals, government publications, and German periodicals.

This collection also contains materials that relate to his personal life outside of the war, including from his time as a lawyer in St. Paul, MN. He also served on the board of Directors at the American National Bank and Trust Company for 25 years, co-founded the Group Health Association of America, and was active in local politics, and he kept letters and documents of these periods of his life.

## Arrangement

The Horace R. Hansen Collection mainly represents the wartime and authorial period of Hansen's work, but it also includes some material relating to Group Health Association of America. The collection is comprised of 13 series in 4 boxes. Material within each series is chronological by subject whenever possible. Prior to receiving and processing this collection, the original order and filing system created by Hansen had been compromised. The current organization prioritizes material type and subject matter and does not reflect Hansen's original ordering system.

WAR CRIMES MATERIAL: Indictments and charge sheets and documents relating to specific WWII war crimes. 7. HITLER'S STENOGRAPHERS AND STAFF: Manuscript accounts from Hitler's stenographers (1942-1947, Bucholz's recounting of The Attempt on Hitler's Life (1944), and Erich Kempka's (Hitler's personal chauffeur) testimony. 8. NEWSPAPER CLIPPINGS: Hansen's collection of newspaper clippings from the 1940s. 9. CORRESPONDENCE: Hansen's "Dear Folks and Friends" letters written home during the war, and other letters written to/from Hansen between 1944 and 1987. 10. PHOTOGRAPHS: Photos from Hansen's time in Europe during the war, travel elsewhere, military photos, and postcards collected by Hansen. 11. INTERVIEWS: Notes and transcripts of interviews conducted by Hansen in 1984-1985 of William (Bill) Borth, William D. Denson, and Dr. Ewald Reynitz. 12. WITNESS TO BARBARISM: Draft and research material for Hansen's book, Witness to Barbarism. 13. PUBLICATIONS: Military manuals, government and military publications, and other publications and periodicals from Germany and later in Hansen's life.

A fifth box contains Hansen's personal notebooks, book manuscripts, and photo slides. The collection also contains a scrapbook of newspaper clippings, copies of Dachau trial transcripts from the National Archives, certificates and awards received by Hansen (framed and oversize), and cassette tapes of Hansen's interviews and a speech given in 1986, which are all digitized.
